NOTICE OF SPECIAL ELECTION

A RESOLUTION CALLING FOR A SPECIAL ELECTION TO BE HELD BY THE JOHNSON COUNTY ELECTION COMMISSIONER IN ACCORDANCE WITH THE SCHEDULE FOR THE NOVEMBER 5, 2019 GENERAL ELECTION FOR THE PURPOSE OF ELECTING A WARD 3 COUNCIL MEMBER TO FILL A VACANCY IN OFFICE WITH AN UNEXPIRED TERM ENDING ON THE SECOND MONDAY IN JANUARY OF 2022.

WHEREAS, a written resignation on September 12, 2018 created a vacancy in the office of Council Member for Ward 3 of the City of Shawnee; and

WHEREAS, pursuant to Section 7 of Charter Ordinance 45 of the City, in the event of a vacancy in the office of Council Member from May 2 to December 31 of any year, the remaining Council Members present and voting, may act to fill the vacancy until the completion of a special election called as provided by law, at which time a Council Member shall be duly elected for the unexpired term and shall take office upon oath or affirmation and certification of election results; and

WHEREAS, pursuant to Section 7 of Charter Ordinance 45 of the City, there shall be a primary election in the event there are more than two (2) candidates for such office.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SHAWNEE, KANSAS, AS FOLLOWS:

PARAGRAPH 1. A special election is hereby called to be held by the Johnson County Election Commissioner in accordance with the schedule for the conduct of the November 5, 2019 General Election, in the manner prescribed by law for the purpose of electing a person to the office of Council Member for Ward 3 of the City of Shawnee, for the unexpired term ending the second Monday in January of 2022.

PARAGRAPH 2. In the event there shall be more than two (2) candidates for such office, there shall be a primary election to be held by the Johnson County Election Commissioner on August 6, 2019 in the manner prescribed by law.

PARAGRAPH 3. Wherefore, the Johnson County Election Commissioner is hereby authorized to proceed with the notice and conduct of a special election for the purpose of electing a person to the office of Council Member for Ward 3 of the City of Shawnee, for the unexpired term ending the second Monday in January of 2022.

PARAGRAPH 4. Wherefore, in the event there shall be more than two (2) candidates for such office, the Johnson County Election Commissioner is hereby authorized to proceed with notice and conduct of a primary election on August 6, 2019 to be held by the Johnson County Election Commissioner in the manner prescribed by law.

PARAGRAPH 5. Candidates for the vacant office shall file a declaration for such office as provided in K.S.A. 25-21a03 and K.S.A. 25-2110a, and amendments thereto.

PARAGRAPH 6. The deadline for filing of candidates shall be 12 noon June 3, 2019.

PARAGRAPH 7. The candidate receiving the highest number of votes at the special election conducted on November 5, 2019 shall upon certification of the election results assume the office of Council Member for Ward 3 of the City of Shawnee, for the unexpired term ending the second Monday in January of 2022.

PARAGRAPH 8. This Resolution shall be published one (1) time in an official City newspaper.





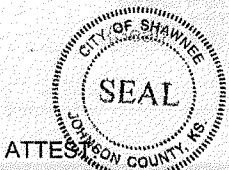
